TERMS AND CONDITIONS OF BOOKING

Booking Conditions

Please note that it is essential to read and understand the conditions of booking below. Please ensure you have read and understood the itinerary and style of the trip/s you are booking. Women's Own Adventures in conjunction with The Travel Authority accepts bookings subject to the following conditions:

validity

The prices listed are based on the costs and exchange rates current at the time of quoting. Women's Own Adventure and The Travel Authority reserve the right to alter these prices at any time. All information is accurate to the best of our knowledge at the time of quoting, but please note that changes to our trips (which can be significant) can and do occur. We will make every effort to keep you informed of any changes, but cannot be held liable for any alterations made to the published itineraries.

cancellation by the traveller

Loss of monies paid applies to all cancelled reservations. The date of trip cancellation is the date on which Women's Own Adventure receives the written cancellation. The loss of monies paid is as follows, per person:

- 95 days or more prior to trip departure - Loss of deposit
- Less than 95 days prior to departure - 100% of total cost
- This trip must be paid in full 95 days prior to departure

No refunds will be made if you voluntarily leave a trip for any reason after the trip has begun. Refunds will be at the discretion of Women's Own Adventure if you are involuntarily forced to leave a trip for any reason. No refunds will be made for any accommodation, transport, sightseeing, meals or services not utilised. Please note that these conditions apply to land content only. Different fees may apply to airline tickets. You are strongly advised to take out cancellation insurance at the time of booking which will cover cancellation penalties in certain circumstances (Note: such insurance will not cover a change of mind).

cancellation by Women's Own Adventure

Women's Own Adventure reserves the right to cancel any trip before it is run. Women's Own Adventure reserves the right to cancel any trip at any time prior to departure due to terrorism, natural disasters, political instability, economic conditions or other external events which make it unviable to operate our planned schedule. If Women's Own Adventure cancels a group adventure trip on which you are holding a fully paid booking you may choose between an alternative trip or a full refund. The company is not responsible for any incidental expenses that you may have incurred as a result of your booking such as visas, vaccinations,

non-refundable flights or loss of enjoyment, etc. If the alternative trip chosen is of a lower value than that originally booked then you are entitled to a refund of the price difference. If the alternative tour chosen is of a higher value then you will pay the difference in price.

flexibility

The Client appreciates and acknowledges that the nature of this type of travel requires considerable flexibility and should allow for alternatives. The outline itinerary as given for each tour must therefore be taken as an indication only of what each group may accomplish and not as a contractual obligation in the part of the Company. The Client agrees that the route, schedules, itineraries, amenities and mode of transport may be subject to alteration without prior notice due to local circumstances or events which may include sickness or mechanical breakdown, flight cancellations, strikes, events emanating from political disputes, entry or border difficulties, climate and other unpredictable or unforeseeable circumstances.

Customers are permitted to transfer their booking to another person for a small admin fee subject to there being no additional fees from service providers such as tour operators and airlines.

changes

By the Company: The Company reserves the right to change any of the facilities, services or prices described. While the Company will do its best to operate all tours advertised, reasonable changes in the itinerary may be made when deemed necessary or advisable by the company. If the Company makes a major change the Company will inform the Client as soon as reasonably possible if there is time before departure. The definition of a major change is deemed to be a change affecting at least one day in five of an itinerary. When a major change is made the Client may choose to accept the change or accept another alternative tour offered by the Company. If neither of these alternatives is acceptable to the Client the Company shall refund all monies paid to it by the Client. If the change is due to force majeure or unforeseen circumstances no refund of the tour price or compensation is payable by the Company.

booking amendments

If you wish to change your booking in any way, the following fees will apply:

1. Transfer from one tour to another:
 - Amendment request received by Women's Own Adventure 95 days or more prior to your original tour departure date - AUD\$125 per person per change. A transfer can only be made to a departure date within the current validity.
 - Amendment request received by Women's Own Adventure less than 95 days prior to your original tour departure date - charges as per cancellation fees.
 - If there has been any change in the price of the tour you change your booking to, since the time of your original reservation, the new tour price will apply to the new reservation. These fees are in addition to any charges levied by hotels, ground operators or airlines.
2. Changes to any other arrangements made in conjunction with your tour booking (eg: hotels, transfers, etc.)
 - Amendments to any other arrangements made in conjunction with your tour reservation will incur an AUD\$50 administration fee per booking per change. This fee is in addition to any charges levied by hotels, ground operators or airlines.
3. No amendments are permitted to your booking within 10 days of departure.

late bookings

For bookings made within 15 days of departure, Women's Own Adventure reserves the right to charge a late booking fee of AUD\$50 per booking. On some trips it is not possible for us to accept late bookings.

insurance

Travel insurance is compulsory for all Women's Own Adventure travellers. Your travel insurance must provide cover against personal accident, medical expenses, emergency repatriation and personal liability. We also recommend it covers cancellation, curtailment and loss of luggage and personal effects. We strongly recommend that you take out travel insurance at the time of booking.

responsibility

You acknowledge that travel on a Women's Own Adventure trip requires a degree of flexibility and understand that the trip's route, accommodation and modes of transport are subject to change without prior notice due to local circumstances. Should Women's Own Adventure deem it advisable to amend an itinerary for any reason, it may do so by shortening, varying or re-routing any trip. These changes are binding and additional expenses will be charged to you if the reason for any alteration is outside the company's control. While travelling with Women's Own Adventure you agree to accept the authority of the leader and local operator at all times. You are aware that travel within a group may involve compromise to accommodate the diverse desires and physical abilities of group members. You understand that Women's Own Adventure reserves the right to decline, accept, or retain any person as a member of the group at any time. You acknowledge that Women's Own Adventure contracts with a network of companies, government agencies and individuals to assist in the running of its tours. To the best of Women's Own Adventure's knowledge, these third parties are qualified to perform the duties they are contracted to perform. However Women's Own Adventure will not be held liable for any injury, damage, loss, delay or irregularity that may occur due to the behaviour of these third parties. Women's Own Adventure will not accept responsibility or liability for any traveller who contravenes any law or regulation of any country visited. No employee, servant or agent of Women's Own Adventure has authority to vary these conditions.

participation form

All Women's Own Adventure travellers on group trips must sign a Participation Form.

Please note that signing the form is a pre-requisite of travelling with Women's Own Adventure.
